4. Missing Pet Recovery Expenses

Cover for eligible boarding expenses under the policy terms.

6. Third Party Liability

Protection if your pet accidentally causes injury to another person or damages third-party property.

What Is Generally Not Covered?

Please note that exclusions may apply, including:

- Pre-existing conditions
- Illness occurring during the first 14 days from commencement of the first policy, except accidental injury
- Congenital and hereditary conditions
- Breeding, pregnancy, infertility and impotence
- Organ transplants, cosmetic or elective procedures, hormone replacement therapy, alternative therapy and weight treatments
- Routine and preventative treatments
- Dental treatments
- Preventable diseases such as parvovirus, distemper and rabies, unless your pet has received up-to-date vaccinations
- Prescription food for general health

Always refer to the policy wording for the full terms, conditions and exclusions.

Who Is Eligible?

The policyholder must:

- Be **18 years old** or above; and
- Be **the owner** of the pet at the time of application.

The policy is available for eligible cats and dogs that:

- Are **micro-chipped**
- Meet the **applicable licensing** requirements for dogs
- Are between **12 weeks and 9 years old** at the commencement of the policy

*The policy **does not** cover banned or restricted breeds, working pets, pre-existing injuries or physical disabilities, subject to the policy terms.*
